

## CONSENT TO STORE AND PROCESS PERSONAL DATA and to STORE AND PROCESS THE INFORMATION SHARED THROUGH MARKETPLACE PLATFORM

1. **Personal data** : I hereby give my consent to the European Clinical Research Infrastructure Network (ECRIN-ERIC) to store and/or process my personal data to respond to, or to submit a clinical trial synopsis at the Marketplace platform
  - I understand that ECRIN will store and use my personal data for the following purposes: submitting a clinical trial synopsis to the Marketplace; sending a message of interest to researchers interested in similar questions, or for the purpose of responding to a question or inquiry I sent via the contact form.
  - I understand that by consenting to participate in Marketplace initiative I may be contacted by researchers interested in similar questions.
  - I understand that ECRIN will be working with the company Akabia, which is a web development communication agency with a head office in France and using servers in France, contracted for the purpose of providing technical support for the Marketplace. ECRIN as data controller and Akabia as data processor will be authorized to process my data only for the above mentioned related purposes.
  - I understand that ECRIN and Akabia will retain my data (name investigator, institute, city, country, email address, and the clinical trial outlines: Title, objective, patient population, intervention, comparator, outcome, rationale, additional file) for as long as relevant for the intended purposes; after this point the data will be deleted. ECRIN will not use and will not authorize Akabia to use the information for other purposes than those mentioned above
  - I understand and agree that ECRIN's website and Marketplace can be seen throughout the world, and not just in the European Union where the data protection regulation (i.e. the GDPR) applies. ECRIN and Akabia have developed their own standing Data Protection Policy, for ECRIN [<https://ecrin.org/data-privacy-policy>] and for Akabia [<https://akabia.fr/politique-de-confidentialite>].
  
2. **Information shared via the Marketplace platform (e.g. Protocol synopsis, etc) ( the "Information")**
  - I state that I am the legal proprietor of the information linked to the clinical trial synopsis as well as of any other information that I submit to the Marketplace, and that this information is not confidential. I understand that it is strongly advised that a formal confidentiality agreement has been signed before any confidential information or other sensitive information including but not limited to information subject to intellectual property protection is disclosed in any communications with other parties through the Marketplace platform.
  - I acknowledge and understand that ECRIN shall assume no responsibility or liability for any damages incurred as a result of the storage and use of the Information you provided by participating in Marketplace platform. Any reliance you place on such information is therefore strictly at your own risk. You need to make your own enquiries to determine if

the information is appropriate for the intended use and can be freely shared through Marketplace platform.

- I acknowledge and agree that ECRIN may be required, in certain circumstances (e.g. requested by law or by any authorities) to disclose the Information in good faith.
- I am granting ECRIN the permission to use, reuse, share, publish, and/or republish in whole or in part, the Information I submitted, without restrictions as to changes or alteration, for the purpose of the ECRIN website and Marketplace.
- Further, I hereby transfer and assign to ECRIN the exclusive right to use, publish or reproduce and to authorise others to use, publish or reproduce, internally and publicly, all or part of my submission.
- In addition, I acknowledge and agree that the stored information may be used without notice and without compensation, or obligation of any kind to me.
